I trust that my email finds you in good health.

SUBJECT: Mandate Letter to Lobby the Government Authorities in the Republic of Uganda; Zimbabwe & Burundi, seek their audience to meet with the State of The African Diaspora - SOAD to engage on the Discussions of Cooperation (SOAD) & convention (UNASDG) agreement that will enable funding for all SDG related Projects in your countries.

**MANDATE RESOLUTION:** Accordingly with the Constitution of the State of the African Diaspora and in my capacity as the Minister of International Co-operations in SOAD, you are duly authorized to lobby your Government and request a meeting between the government of these countries under your jurisdiction and the SOAD team lead by the Prime Minister of SOAD, HE. Dr Louis-Georges Tin who resides in France having representation in many different countries including South Africa which is my home country.

**VISION OF SOAD**: The intention is to foster relationships and discuss further on the mission to bring development in the African Continent on all the SDG related projects and bringing Humanitarian Funds which comes from the UN Alliance in the form of UNASDG, which shall be released once agreements have been reached and the cooperation has been signed between the Government & the State of African Diaspora – SOAD. There are two (2) letters that shall be sent to your Government to provoke the process of cooperation agreements. These letters are listed as follows:

- 1. Letter of Cooperation Agreement SOAD
- 2. Letter of Convention Agreement for the release of humanitarian funds by the UN Alliance UNASDG

Your mission is to support the vision of SOAD State, to your government, explain its philosophy, and help us get the incorporation & the convention agreement signed so that we can implement our development programs, under the auspices of the Prime Minister of the State of African Diaspora, HE. Dr Louis-Georges Tin.

The State of African Diaspora is seeking an audience with the State Officials/ Representative from your government who are eligible to sign the two (2) letters, for further engagements and discussions. Any one of these Govt. Officials can but ONLY one of them can sign per country except in the case of the Province where the Premier can sign on behalf of his/her Province. They are listed below as follows:

- The President :
- The Vice President/ The Prime Minister :
- Minister of Foreign Affairs :
- Minister of International Cooperation
- In the case of the Province:
- The Premier (Governor) is the only one who is duly Authorized to sign the (2) documents.

**BACKGROUND OF Pen CT & IT'S RELATIONSHIP WITH SOAD:** Pen CT a company from South Africa which specialize in the SDG related projects has alliance partners in SA & beyond. In cases of successful engagement for the projects of mutual interest Pen CT shall sign an NCNDA agreement with the local partners who are recognized by the government & its alliances for those projects of mutual interests. An NDA by SOAD shall be signed with all parties that will be involved with SOAD. **SOAD:** has a signed MOU agreement with Pen CT and its partners as according to the agreement sworn between all parties in the NCNDA, to implement the projects of mutual interest as is agreed to with the State that is incorporated & receiving funds from the Diaspora.

With this partnership agreement SOAD shall oversee and provide funding to all projects that shall be assigned by the government of the country incorporated by SOAD, to Pen CT & its Alliance partners which are in SA & beyond, and for the benefit the vision of African Diaspora in terms of the Vision 2063 and the National Development Plan (NDP) of the Country that will be receiving funds.

We hereby apologize for the short notice but the SOAD has given assurances that the meeting will be beneficial to both parties in that the release of these Humanitarian Funds by UN Alliance in alliance with SOAD, which comes with NO pay back (NOT A LOAN) shall be released to the central bank of SA soon as the agreements have been reached and the two (2) documents of cooperation & convention has been signed.

We trust you, and we count on you to reinforce Africa through the diaspora, and the Diaspora through Africa. We are looking forward to hear from you.
